

Client Bill of Rights

Education and Training: I was trained in hypnotism at the Paris VI university and at the Psychosomatic Medicine Institute of clinical hypnosis and brief therapy (Paris).

I was a physician in France and I did medical hypnosis. Continuing both hypnotism and general practice was a time consuming challenge, so I decided to stop practicing medicine in order to devote myself exclusively on hypnosis and thereby maintain my training at a high level. Since then I practice non medical hypnosis. I am no more a licensed health care practitioner neither in France nor in the USA. I am not board registered.

Notice: As the state of Michigan has NOT adopted educational and training standards for the practice of hypnotism, this statement of credentials is FOR INFORMATIONAL PURPOSES ONLY. **Hypnotism is a self-regulating profession and its practitioners are not licensed by state governments. I may not provide a medical diagnosis nor recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis or any other type of treatment from a different practitioner, the client may seek such services at any time. In the event my services are terminated by a client, the client has a right to coordinated transfer of services to another practitioner. A client has a right to refuse hypnotism services at any time. A client has a right to be free of physical, verbal or sexual abuse. A client has a right to know the expected duration of sessions, and may assert any right without retaliation.**

Ethics: I practice in accordance with the [National Guild of Hypnotists's Code of Ethics and Standards](#).

Confidentiality: I will not release any information to anyone without a written authorization from you, except as provided for by law. You have a right to be allowed access to my written record about you.

Fees: The charge for my services are \$ 120 per consultation. There won't be any change in fees during your hypnosis session block. There are no cancellation charge, please let me know as soon as possible when you need to postpone a session. I don't take insurance.

Insurance: I suggest you think of my services as something that you will pay for personally. That will both protect your privacy and help you value the work you are doing more. In general insurance companies don't cover hypnotic services and I caution you not to expect them to do so.

My Approach: Hypnotism is an effective and scientifically proven technique. The hypnosis technique that I practice is respectful of free will and therefore only works on clients wishing to do hypnosis. I value self empowerment, the client is always free and awake during all sessions. I suggest to also address the issues directly related to your reason for consultation: for example if you want to quit smoking but you cannot because you gain weight as soon as you quit, we should work on weight loss too.
